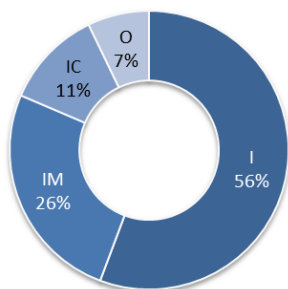

## Munich & Frankfurt Investor Forums 2015
